City Code Section 14.30 - 14

(a.) All conductors installed in building within the fire districts shall be enclosed in Rigid Metal Conduit, Intermediate Metal Conduit (IMC), Electrical Metallic Tubing (EMT) or Type MC Metal-Clad Cable.

(b.) All service entrance conductors serving buildings within the fire districts or limits shall be enclosed in Rigid Metal Conduit.

(c.) All service entrance conductors shall be installed in an approved raceway for all buildings. Service changes shall meet this requirement.

It is hereby agreed between the undersigned, as owner, his agent or servant, and the City of Kaukauna, that for and in consideration of the premises and of the permit to construct, erect, alter or install and the occupancy of building as above described to be issued and granted by the Building Inspector, that the work there on will be done in accordance with the descriptions herein set forth in this statement, and it is further agreed to construct, erect, alter or install and occupy in strict compliance with the City of Kaukauna Code of Ordinances and all amendments thereto; and to obey any and all lawful orders of the Department of Building Inspection of the City of Kaukauna.
